Dear Friends,

As the economy sails in the 8% plus growth trajectory, the old concerns of inflation have begun to creep up again. Cyclical and structural price escalation has been one of the pivotal features of the Indian economy. The inability of the production factors to match-up with rising income and consumption preferences has seen aggregate demand outstrip supply almost regularly. In that context, the present bout of inflation is only marginally different, since the abysmal failure of

monsoon has helped aggravate the prices equation.

But a break from this trend is necessary. As RBI governor has himself affirmed that 'pure' inflation targeting by the policy initiatives is less relevant in Indian context. Key reason for this phenomenon is the supply constraint and the weak monetary transmission mechanism. Therefore it has become essential that policy makers adapt concerted attempts at not just expanding production, but also productivity.

For the present, the policy move by RBI to hike repo and reverse repo rates by 25 bps each, indicates the rising urgency for reining into inflation. Further, there is a general consensus that the April policy meet may see further rate hike.

This, coupled with the fact that RBI has front loaded nearly 62% of its Rs 457000 Cr FY11 borrowing programme in the first half, adds pressure on the bond market sentiment. Therefore, it is expected that the virtual absence of OMO and the concurrent liquidity tightening, may cause the gsec yields to move further north.

Although, the debate about the resultant impact of the rate hike on the cost of domestic capital is still unsettled! The late resurgence in credit offtake has seen the growth rate cross the 16% yoy mark. This is a remarkable improvement from 13.7% rate in Dec-09. But despite this performance, the credit growth continues to lag industrial activity.

For that reasons, there is a set of opinion which suggests that rising cost of capital may impede credit-offtake and restrain the economic growth to current levels. To which, I do not fully agree with.

In my opinion, the up-gradation in India's sovereign ratings, and the rising risk appetite in the international markets; provides Indian corporate sector with feasible borrowing opportunities in overseas capital markets. This may consequently offset the impact of high cost of borrowing; if and when, that phenomenon sets-in. In fact, going by the suggestion of some reports, the net capital inflows may touch nearly US\$ 90 bn in 2010.

Meanwhile, the growth consideration of the equity markets is based on the likely upstart in the private investment; and the indications of further FII inflow. The equities market presently is trading in a narrow band with an upward bias. It remains therefore susceptible to cues, and may await the results season in April to garner further guidance.

In conclusion, the swift economic reversal from Oct-08 lows has brought the Indian economic growth rate to almost pre-crisis levels. The next phase of the growth ambition has to centre on accelerating the economy to 9%-plus; and then to the double-digit growth level. The evolving Dollar-Yuan valuation debate may present India one such opportunity. In this context, it is essential that the social and physical infrastructure is in place to compete for such openings.

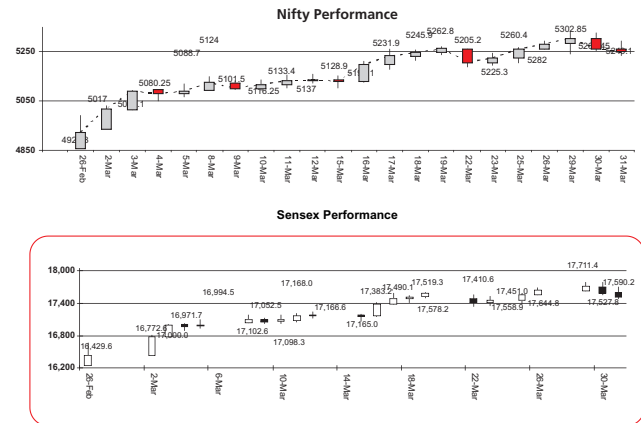

Equity Market View

The market performance in Mar-2010 reflected the buoyancy and optimism of growth coming back into the Indian economy. The key equity indices, Sensex and Nifty, witnessed a robust performance of 6.68% and 6.64% respectively. The upward trend in the market was on account of growth oriented budget, improved sovereign standing and the consequently expanded FII participation. In fact, FII investment of US\$ 4.37 bn in Mar-10 was only last outdone in Oct-07 when the net FII inflows accounted nearly US\$ 5.27 bn.

The performance of sectoral indices reflected the interplay of the specific factors intrinsic and peculiar to each sector; and therefore varied accordingly. The top sectoral gainers in March month were Consumer durables (5.3%), IT (3.94%) and Auto (3.13%). On the other hand, Realty (-7.53%), Oil & Gas (-3.45%), and Power (-3.27%) remained on the lag end of sectoral indices performance chart.

The Sensex and Nifty performance displayed a daily returns variance (risk) of 0.669% and 0.68% respectively. The average daily cash volume in Nifty in the March-2010 month increased by 11.2% to Rs 13630.7 crs. On the y-o-y basis, the average daily cash volume in Nifty increased by 41.14%. The aggregate cash volume in Nifty for the period of March-2010 was recorded at Rs 2,86,245.54 crs - a gain of 16.77 % over February month. The volume of average daily contract in F&O Market in March month decreased marginally by -.11% (source: NSE).

Other Economic News

The balance of payment status for Q3-FY10 remained robust, witnessing a net growth of US\$ 1.7 bn for the period. The merchandise trade account posted a negative balance of US\$ -4% q-o-q. This was despite the sluggish growth of imports, which expanded at 2.57% yoy. In the same period, the growth in exports registered a 13.22% yoy growth. However, the less than anticipated growth in invisibles inflows kept the current account deficit at largely previous quarter levels.

In the same period, the capital account saw a net inflow of US\$ 14.7 bn in Q3-FY10. Overall, in the Apr-Dec 09 period, the surplus capital account has accounted for nearly US\$ 43.2 bn. This capital inflow buoyancy is on account

of large movements under FDI, FII, and short term credits. As per the data, the economy has witnessed a net FDI inflow of US\$ 16.5 bn in the Apr-Dec 09 period.

Market Outlook

The markets are currently a function of liquidity interplay resultant from large FII inflows. In absence of any negative cues from the overseas markets, the equity performance is expected to remain buoyant. However, the specter of rising interest rates has placed a restraining factor on the cost of capital, for both: fresh capex investments and regular working capital expenditure. Therefore, the uncertainty surrounding the likely impact of rate hikes remain.

But given the improving investment outlook in the overseas markets, especially with regard to India, the overseas borrowings may offset the domestic cost of capital. Also, the upcoming earnings season may provide guidance for future course of market direction. We remain optimistic of the growth potential of the Indian equities market, and expect it to perform in line with nominal rate of growth in the economy.

Inflation

The inflation in the primary goods segment continued to remain buoyant. The yoy inflation in the primary goods index registered a growth of 13.86% (as on 20th Mar 2010). In the immediately preceding week ended 13th Mar 2010, the inflation in the primary goods segment was recorded at 13.88%. In the same period last year, the inflation in primary goods segment was at 5.20%. The price growth in the primary goods segment continues to be dictated by the price hike of food commodities like cereals and fruits.

On the other hand, the prices of the select commodities in the energy and related segment have also begun to show early signs of renewed inflationary trend. The inflation in Fuel & power segment stood at 12.75%. During the same period last year, the inflation this segment was at -6.11%.

Deposit and Credit Growth

The credit growth continued to gain pace in the Mar period. The rate of growth in the aggregate credit segment was around 16% yoy. Although in the same period last year, the credit growth was in the region of 18.2%. The growth uptick since Jan month was largely on account of increased credit allocation to the commercial sector. The credit allocation in this segment since Jan has been around Rs 109074 crs. This is nearly 31.22% of the fresh incremental allocation made so far in FY10.

The mobilization of the aggregate-deposit also remained in line with the trend, growing at a moderate pace of 18.1% yoy. In the same period last year, the deposit mobilization rate was around 21%.

Outlook

The 25 bps hike in repo and reverse repo rate each by RBI is being seen as a precursor to the awaited annual policy review on 20th April 2010. There is a general market expectation that the central banker may adopt a hawkish position with respect to interest rates; given the buoyancy in inflation. To aggravate that fact, government plans to frontload nearly 62% of the borrowing programme in H1-FY11. (Source: RBI) This, compounded with liquidity calibration measures by RBI, may see a gradual hardening of yields, especially in the 5-14 yr paper segment. In such a backdrop, we believe that the 10 yr gilt may continue to remain firm, and might trade in the range of 7.80%-8.10% in the following month.

Gold Corner

For the march month, the Gold prices closed at \$ 1109.50 per ounce, down \$ 3 or 0.27% mom from Feb end. Price of the yellow metal opened the month of March at \$1117.25 per ounce. Intra month it touched a high of \$ 1136.25 per ounce. The decision by the Fed to keep record low interest rates has helped keep a floor on gold prices. The assets managed by Gold Exchange Traded Funds in the country increased to Rs. 1583 crore as on Feb 28, 10 from 1425 crore as on Jan 31, 10. (the data is available with a 1 month lag)

Outlook

World Gold Council has made projections on future demand for gold in China. According to the said report, (Source: World Gold Council) Chinese demand may double in the next decade. More importantly this significant increase in demand may come at a time when production internationally has been falling in recent years.

Table below shows the percentage of world mine productions of top four countries from 1995 to 2008. Only China has able to double its mine production during this period. Chinese demand from investors and the jewellery industry, which now accounts for 80% of purchases in China, reached 423 metric tonnes in 2009, while domestic mine supply was 314 tonnes. The output shortfall may create a "snowball effect" as the country's

production fails to keep pace with the annual leap in consumption.

As per World Gold Council, higher mine development costs, potential supply disruptions, tougher safety regulations and depleting ore bodies could put a much higher floor under the gold price. Indeed the favourable supply-demand fundamentals mean that gold may be well supported with a floor of around \$1,000/oz. Further, terrorism remains a risk, and the risk of a military confrontation between North Korea and South Korea remains real. Geopolitical tensions being witnessed in Russia and North Korea are all supporting gold, since volatile political or economic developments tend to drive increased fund flow into gold assets.

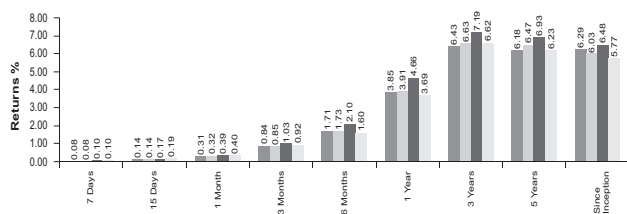
